WHEREAS the Municipality has been attempting to secure an Environmental Compliance Approval (ECA) to expand the existing municipal village landfill since 2009, and has been engaged with the Ministry of the Environment, Conservation and Parks (MECP) through the ECA pre-consultation process since 2018, with the following more recent milestones:

- The Municipality received a review of pre-submission materials prepared by WSP (formerly Wood) on August 14, 2020;
- A meeting was held between MECP and WSP on August 27, 2020 to clarify outstanding MECP pre-consultation requirements;
- WSP submitted the requested pre-consultation outstanding information requirements to MECP on October 19, 2020;
- The Municipality received further review comments from the MECP on November 12, 2020 indicating that further information was still required, but that there was general agreement on the required items and final approach to resolution;
- WSP provided a final response to MECP on June 1, 2021, believing that this response included the final information requirements requested by the MECP.

However, on March 22, 2022 the Municipality received a further more extensive set of review comments on previously submitted materials, provided by a different MECP technical reviewer (29 requests), that in large part seemed to ignore much of the progress achieved with the original MECP technical reviewer.

A response to this latest set of MECP review comments was provided to the Ministry on December 22, 2022. The Municipality has yet to hear back from the MECP on this latest set of responses.

The overall review process with the Ministry has become excessively prolonged and technically complicated considering the scale of the undertaking (expansion of a small municipal landfill), and needs to be brought to a practical and achievable resolution. The Municipality simply does not have the resources to continue with this prolonged and uncertain review process.

NOW THEREFORE Mayor Reider will address a letter to the Minister of Environment, Conservation and Parks requesting a prompt resolve to this matter. With copies to go to our MP’s and MPP’s and the manager of the Sudbury MECP office AND THE Minister of Municipal Affairs.
