25-154 BY NIKOLA GRUBIC – PEGGY ROQUE

WHEREAS the Council of the Municipality of Killarney acknowledges receipt of the letter from the Honourable Rob Flack, Minister of Municipal Affairs and Housing, announcing the expansion of strong mayor powers and duties to the heads of council in an additional 169 municipalities;

AND WHEREAS these expanded powers, effective May 1, 2025, now apply to the Municipality of Killarney;

AND WHEREAS the intent of the Strong Mayors, Building Homes Act, 2022 and O. Reg. 580/22 is to equip mayors with tools to advance shared provincial-municipal priorities, including the acceleration of housing construction and associated infrastructure development such as:

- Transit;
- Roads;
- Utilities; and
- Servicing;

AND WHEREAS O. Reg. 530/22 outlines additional powers granted to mayors, including:

- The ability to appoint the Municipality’s Chief Administrative Officer;
- The authority to direct certain municipal employees, hiring certain municipal division heads as well as the ability to restructure municipal divisions;
- The power to create committees of Council, assign functions and appoint their Chairs and Vice-Chairs;
- Veto power over certain by-laws that the mayor is of the opinion that there is a conflict with provincial policies;
- The power to propose the annual municipal budget, subject to Council amendments;
- The authority to propose by-laws that could potentially advance a provincial priority;
- The authority to bring forward matters for council consideration if the mayor is of the opinion that considering the matter could potentially advance a provincial priority.

AND WHEREAS Mayor Reider believes that this concentration of authority diminishes the role of elected municipal councillors and undermines democratic governance by reducing transparency, accountability, and the vital role of elected municipal councillors who were elected to represent their constituents equally and collaboratively;

THEREFORE BE IT RESOLVED THAT Mayor Reider hereby formally declines the powers and duties assigned under the Strong Mayors, Building Homes Act, 2022, O. Reg. 530/22, and O. Reg. 580/22;

AND FURTHER THAT Mayor Reider affirms his commitment to the democratic principle of one vote per elected Council member and the long-standing majority rule system which has served the Municipality of Killarney effectively for decades;

AND FURTHER THAT this resolution be forwarded to:

- The Honourable Rob Flack, Minister of Municipal Affairs and Housing;
- The Honourable Doug Ford, Premier of Ontario;
- Our local Members of Provincial Parliament (MPPs);
- The Association of Municipalities of Ontario (AMO); and
- The Association of Municipal Managers, Clerks and Treasurers of Ontario (AMCTO).

25-155 BY NIKOLA GRUBIC – PEGGY ROQUE

WHEREAS the Government of Ontario announced on April 9th, 2025 that it was extending “Strong Mayor Powers” to an additional 169 municipalities, including the Municipality of Killarney, effective May 1, 2025; and,

WHEREAS the Province only accepted comments on the government’s intentions until April 16, 2025 with the new powers set to begin on May 1, 2025; and

WHEREAS the timeline for feedback from municipal councils was unreasonably short; and

WHEREAS Strong Mayor Powers erode the democratic process and have fundamentally altered the historic model of local governance, which has existed for decades by:

- providing the head of council with the authority to unilaterally give direction and make certain decisions without a consensus from a majority of the members of council; and,
- creating a power imbalance by providing the head of council with special powers that other members do not generally have.

WHEREAS the Strong Mayor powers significantly alter the balance of governance at the municipal level, undermining the role of Council in decision-making, diminishing the role of elected municipal councillors and weakening the fundamental democratic principle of majority rule; and,

WHEREAS this proposal has raised significant concerns regarding the centralization of power, erosion of local democracy, reduced accountability and the potential for the abuse of power; and,

WHEREAS the Municipality of Killarney has a long history of collaborative, transparent, and accountable local governance built upon a foundation of Council-debate and shared decision-making; and,

WHEREAS the Province claims that Strong Mayor Powers will get homes and infrastructure built faster, reduce red tape and accelerate the deliver of key priorities; and

WHEREAS research from the Association of Municipal Clerks & Treasurers of Ontario (AMCTO) has identified that there is no evidence to suggest this legislation has any impact on the number of housing starts in municipalities that have been granted the powers; and

WHEREAS many municipally elected officials across the province and members of the public have expressed significant concern regarding the imposition of these powers; and,

WHEREAS the Municipality of Killarney did not formally request or express a desire to be designated under the Strong Mayor framework; and,

WHEREAS a growing number of municipalities and elected officials across Ontario are questioning the appropriateness of the Strong Mayor system and are calling for its reconsideration or repeal;

THEREFORE BE IT RESOLVED that the Council of the Corporation of the Municipality of Killarney resolves to reject the Strong Mayor Powers granted to it in order to preserve local democracy, transparency and accountability and hereby requests the Premier of Ontario and the Minister of Municipal Affairs and Housing to immediately remove the Municipality of Killarney from the list of municipalities designated under the Strong Mayor legislation, or repeal the legislation, or offer the option to municipalities to opt out of Strong Mayor Powers;

AND BE IT FURTHER RESOLVED that a copy of this resolution be sent to the Premier of Ontario, the Minister of Municipal Affairs and Housing, all regional Members of Provincial Parliament, and the Association of Municipalities of Ontario (AMO) and AMCTO.
