The Board's current Plan was approved in 2010. The Official Plan Review has updated and refined the goals, objectives, policies, and schedules to create a new Official Plan for the Planning Area to ensure that it: conforms with Provincial Plans; has regard to matters of provincial interest; is consistent with the 2020 Provincial Policy Statement; and updates matters of local interest.

The proposed Official Plan applies to the entire Planning Area.
