BY-LAW NO. 2016-34

BEING A BY-LAW TO AMEND SCHEDULE "A" TO BY-LAW NO. 2016-14 SETTING THE RATES FOR FEES AND SERVICE CHARGES IN THE MUNICIPALITY OF KILLARNEY FOR THE YEAR 2016

WHEREAS Section 9 of the Municipal Act, S.O. 2001 c.25 as amended, provides a municipality with the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority;

AND WHEREAS By-Law No. 2016-09 of the Municipality of Killarney was enacted and passed on the 9th day of March, 2016;

AND WHEREAS By-Law No. 2016-09 was amended by By-Law 2016-14 on the 13th day of April, 2016;

AND WHEREAS Council, deems it desirable to further amend the rates for fees and services in the Municipality of Killarney.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF KILLARNEY ENACTS AS FOLLOWS:

1. That Schedule "A" of By-Law No. 2016-14 be further amended.
2. That amended schedule "A" of this By-Law replaces Schedule "A" of By-Law No. 2016-14 passed by the Municipality of Killarney on April 13th, 2016.
3. That the amended schedule be attached hereto and forms part of this By-Law.
4. That any By-Law or portion thereof previously approved by Council which conflicts with this By-Law shall be hereby repealed.
5. That this By-Law shall take effect on the day of passing.
